

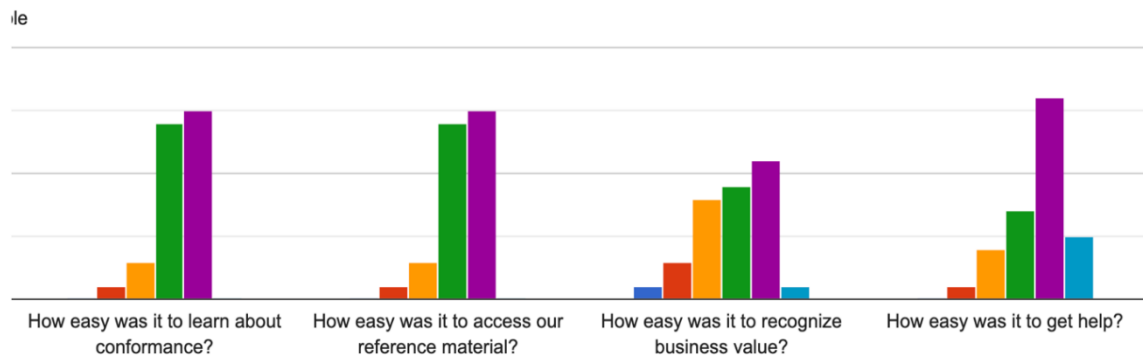

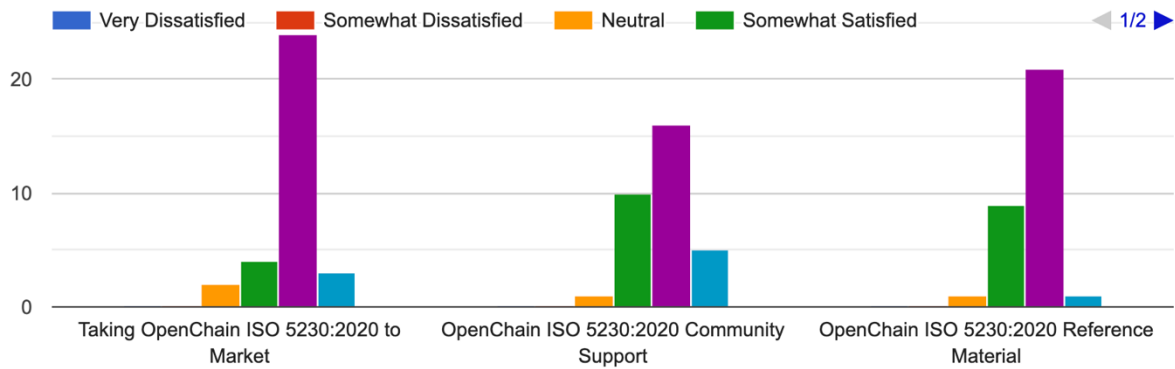
### Engaging with OpenChain ISO 5230:2020



Looking at overall satisfaction – the purple bars (representing “Excellent”) on the first seven questions give us a good overview of where we are. OpenChain is a community that is easy to engage with and we are very easy to get help from/regarding, and the vast majority of respondents believe that we are “Very Good” or “Excellent” in putting forward what we are

doing and sharing our information – either the business value, conformance, reference materials, and our website.

Overall, how satisfied are you with OpenChain in the past year?

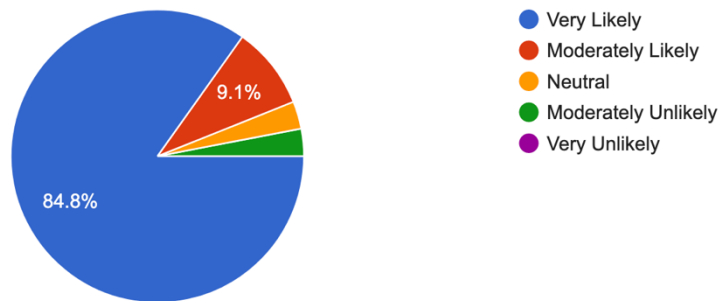


The purple bars have the day here, too, representing “Very Satisfied” responses across the past year.

How likely are you to recommend OpenChain to other companies?

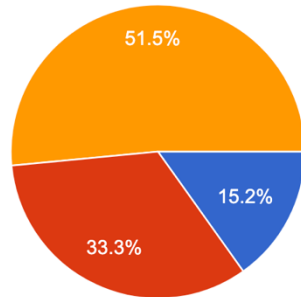

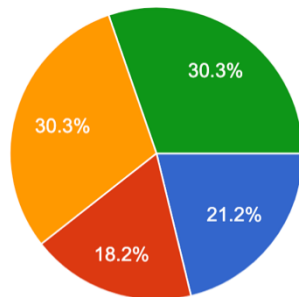

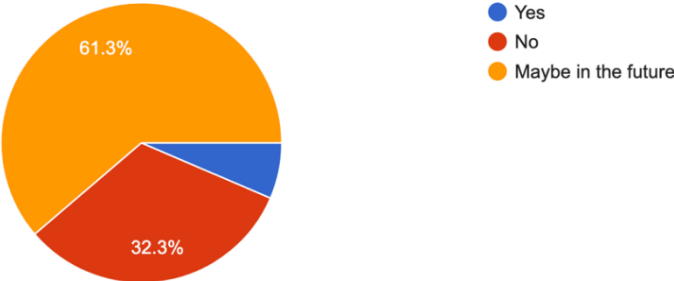

The Conformance story in the survey results is interesting. We find that about half of survey respondents are primarily interested in something other than conducting a private “health check” of a current compliance program or being listed as a company with an OpenChain conforming compliance program. This data point needs qualification. Feedback from our community indicates that a relatively small percentage are seeking public announcements regarding conformance at this juncture. Their focus is instead on internal (or inter-supply chain) improvements and conformance. We additionally have a number of companies engaging with OpenChain ISO 5230 with applications outside of our core scope of conformance for the purpose of license compliance. These include entities engaging for activities related to security, mergers and acquisitions, and other business processes.

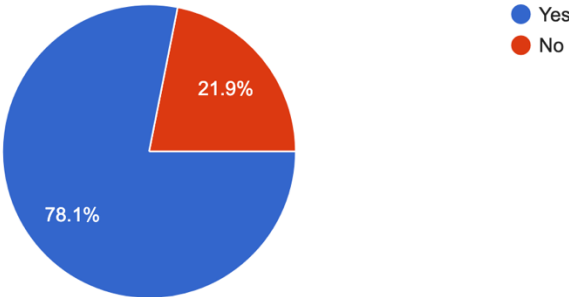

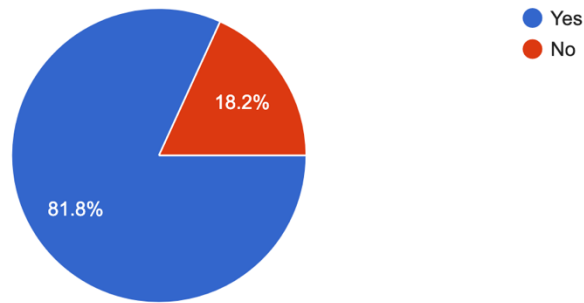
Are you aware of the OpenChain Partners and the services they provide around OpenChain?

Shifting over to automation, while most understand the value of automation, we have room to grow in the ease of understanding interoperability.

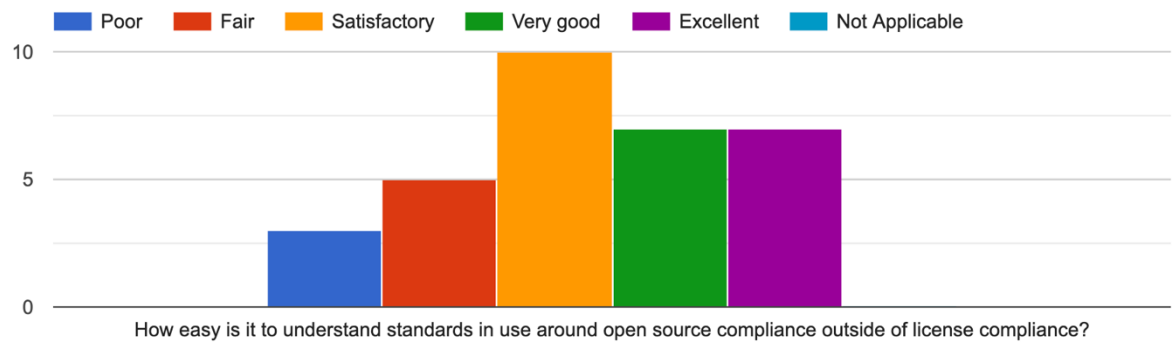

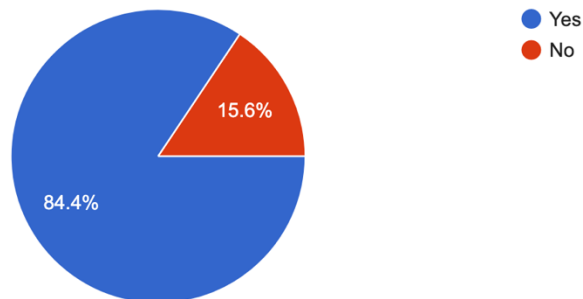
### Interoperability Around Open Source Compliance

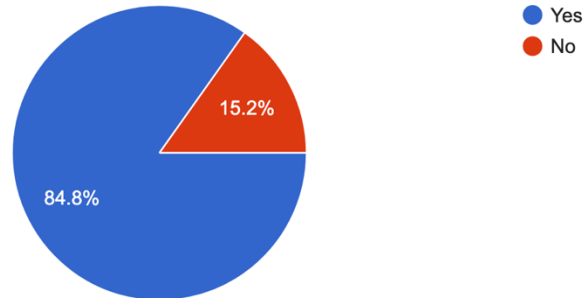
### Would you like to see more support for ingest and export of SDPX?

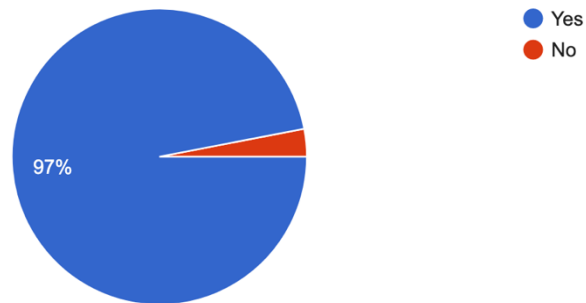
Would you like to see more interoperability between open source and proprietary tools for open source compliance?
